**MARINE AND COASTAL ACCESS ACT 2009, PART 4 (MARINE LICENSING) –  
MARINE CONSTRUCTION LICENCE FOR A NEW OUTFALL PIPE AT DUNLUCE CASTLE,

Thank you for return of the contractor's details form, dated 27<sup>th</sup> August 2019, in respect of the above. Please find enclosed a formal Marine Construction Licence for the construction of a new outfall pipe at Dunluce Castle.

In addition to the conditions specified in the attached licence, the Department would ask you ensure that care is taken around the construction sites so that no unauthorised materials are deposited.

To this end you should ensure that good working practices are employed throughout the works.

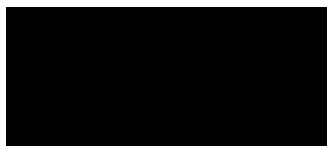

In the worst cases, a person found guilty of an offence may be subject to a fine of up to £50,000 or to imprisonment for a term not exceeding two years or to both.
