<p>The Department of Justice, the Home Office and the Office of the Attorney General and Advocate General for Northern Ireland have launched consultations today to seek views on updates to Codes of Practice issued under the Proceeds of Crime Act 2002 (POCA).</p> <p>The Department of Justice is consulting on the s.195T, the s.293A, the s.377ZA and the s.303I codes. The codes provide guidance on the exercise of the relevant powers in Northern Ireland by constables and accredited financial investigators.
