(NOTE: It is the responsibility of the stall holder to provide their own power supply)
PLEASE NOTE
 A licence is issued to an applicant. In the case of a business please provide details of the person who will be holding the licence. Any person who in connection with an application for the grant, renewal or variation of a street trading licence makes a statement which he knows to be false shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 3 on the standard scale. If a temporary street trading licence is issued the holder should note that the size of the area provided to trade must not be exceeded. Stalls (including gazebos) are no to encroach onto other pitches, roads or open areas. Council recommends that all licensed street traders hold current public liability insurance cover for the protection of themselves and the public. The supply of BB Guns, crossbows or goldfish, either by offering for sale or as a prize, is prohibited. Compliance monitoring will be ongoing to ensure the conditions of respective licenses are being adhered to. Witnessed offences could result in formal action being taken under the above legislation and the licence may not be renewed for the following year's Lammas Fair.
