NILGA Reconstitution post 18th May 2023 Local Government Election

In the run up to the 2023 local government elections, which are being held a few weeks later than is the norm, I felt it was important to contact you to outline some key issues and dates, per the short schedule below, to ensure awareness and understanding of the information we need from councils, and the relevant timeline.

The process involved by way of nominations to NILGA and to enable us to populate councillors on outside bodies through NILGA, is relatively simple.

Key Dates and Issues – Council Elections and Immediate Next Steps

- 18th May Council Elections, 462 members returned
- 23rd May Regional d'Hondt (ALL NI) calculations and preparation of appointments table by NILGA. NILGA will write to each council in relation to their possible proportional representation to the Association.
- NILGA will seek:
 - 8 members from each council (10 from Belfast) for the NILGA 'Full' membership. These nominations should reflect the political proportionality and diversity (in equality terms) of your council members.
 - 1 member (who may or may not be one of the aforementioned 8) to sit on the Elected Member Development Policy and Learning Network. Other policy structures will be populated at a later date.

This will be an important electoral period for local government in Northern Ireland and, as such, NILGA wishes to ensure that the elected council representatives working regionally and on behalf of local government nationally on UK wide investment, pay, performance and other policy bodies, are of the highest calibre possible.

Re: Portrush Sea Cadets - Charity Number 104126

Regarding our 2023 Application for a mooring at Portrush Harbour – Customer Code PORT86, I wish to enquire if it would be possible to consider waiving the mooring/marina and storage fees for our Charity - Portrush Sea Cadets.

I am advised that historically Portrush Sea Cadets would have had berths at Coleraine Marina, however the unit went through a very tough time following the sudden passing of their Commanding Officer in 2017 and was set for closure in early 2021.

An experienced team of volunteers took over command of the unit in May 2021 and with the fantastic support of Causeway Coast & Glens Borough Council, the Harbour Master Mr John Morton and his staff at the Portrush Harbour Office and Portrush and Coleraine Yacht Clubs we have turned the unit around and in 2022 we were awarded a Captain's Commendation from Marine Society & Sea Cadets which puts us in the top 10% of 400 units in the United Kingdom.

We have opened a new Junior Section for young people aged between 9 and up to 12 years old and our Senior Section is for those aged 12 and up to 18 years old – we currently have 27 cadets at our unit and are actively encouraging more to join. We are an independent charity, receive no annual funding and all of our staff are volunteers.

2022 has been a very successful year and we have delivered the following for the benefit of the community of Causeway Coast & Glens:

- An average of 30 boating hours per young person in sailing, rowing, powerboating and paddlesports.
- Participation of young people in local, district and national competitions in football, paddlesports, rowing and ceremonial drill.



- Qualifications for young people and adult volunteers in RYA Youth Sailing, RYA
 Powerboating, Instructor qualifications, CANI Paddlesport Awards, British Rowing, First
 Aid and training for young people in Marine Engineering, Cooking, Navigation,
 Ceremonial Drill and Seamanship
- Community engagements with Primary Schools, RNLI, Royal British Legion, Warm & Welcome Place (Portrush Yacht Club), Litter Picks and Waggy Races at Portstewart

Our volunteers have given in excess of 2350 hours during the past 12 months which at the basic National Living Wage of £9.50 (2022 figures) equates to £22,325.00 for the benefit of our local community.

Please note that the hours listed above are only the hours given whilst directly engaged with young people in lessons or boating, this does not include the immeasurable hours our volunteers give whilst moving boats, cleaning/maintaining our unit and boats, preparing lessons, updating records or fundraising/preparing grant applications.

Ideally our requirements would be as follows:

- Waiving of the fees associated with our mooring at Portrush Harbour for our rigid inflatable boat and associated onshore storage for 4 dinghies (in 2022 we were allocated our mooring and parking for the 4 dinghies).
- Reinstatement of the berths at Coleraine Marina for our rowing boats and rigiflex powerboats and associated storage for boat trailers, with secure storage for our oars and associated boating equipment and waiving of these fees.

With Portrush ranking 105 out of 890 on the Multiple Deprivation Measure list with Crime & Disorder Deprivation ranking 18 and Income Affecting Children Deprivation Domain ranking 32, I hope you will agree that our service to the local community is essential, provides excellent opportunities for young people and one that you could consider agreeing to support further.
