The Department for Infrastructure has appointed the Planning Appeals Commission to conduct an Independent Examination of the Mid & East Antrim Borough Council Local Development Plan, and I am writing to you because you made a representation to the Council regarding their Plan Strategy.

I would like to take this opportunity to introduce Rosemary Daly and Carrie McDonagh as the Commissioners appointed to this examination. The Commissioners are currently completing a series of checks to ensure that all essential regulatory steps have been taken by the council and to identify any fundamental concerns about the soundness of the plan. This is the initial assessment stage. Following this assessment, the Commissioners may request further written evidence and an exploratory meeting may be held. The Commissioners will decide if an exploratory meeting is necessary and who, if anyone, will be asked to submit additional evidence, therefore **you should not submit any further evidence unless explicitly asked to do so.**

**The Commissioners will give every representation the same careful consideration regardless of whether the person who made it is heard at a hearing or not.** If you no longer wish to take part in the examination process please contact me using the details above. Your original representation will still be considered by the Commissioners.

During the examination process the Commission will be using email as our primary means of contact.
