1.0 Purpose of Report

2.2 Proposed Schedule of Council and Committee Meetings June 2023 – December 2023 inclusive

The proposed Timetable of Meetings Schedule has been presented taking into account the Annual July recess³ and key public holiday periods. Rescheduled meeting dates/times have been presented throughout for Council decision, where appropriate.

Council has, to date, held a Planning Committee meeting annually in December. Due to the proximity of the rotation of the Planning Committee meeting to the December holiday period, it is considered that this meeting should not be held.
