The Home Office has launched an open formal consultation on proposals to control the use of Nitrous Oxide. The consultation seeks to understand the full range of legitimate uses of Nitrous Oxide and proposes three options for how to approach a regime of control to enable a minimisation of the burdens placed on those who seek to use and handle Nitrous Oxide for legitimate purposes. This consultation coincides with the UK Government's recent launch of a new Anti-Social Behaviour Action Plan, part of which included an announcement to control Nitrous Oxide under the Misuse of Drugs Act 1971 as a Class C drug. The Home Office's consultation will run for 8 weeks and will close at 11.59pm on 27 June 2023. The Department would encourage all relevant stakeholders in Northern Ireland to respond to the consultation to help in the understanding of the range and scale of legitimate uses of nitrous oxide on order to inform UK wide policy.
