6. LOCAL GOVERNMENT RESILIENCE UPDATE

Report, previously circulated, was presented by the Director of Environmental Services.

Purpose of Report

The purpose of this report is to:

- agree to Causeway Coast and Glens Borough Council continuing to act as the host for the Northern Emergency Preparedness Group (EPG).
- consider and agree an updated Service Level Agreement (SLA) between Armagh City, Banbridge and Craigavon Borough Council and 10 Councils.
- provide an update on key priorities of the Local Government Regional Resilience function.

Background

Article 29 of the Local Government (Northern Ireland) Order 2005 provides Local Authorities with discretionary powers to engage in emergency planning and assist other organisations in disaster recovery.

The Northern Ireland Civil Contingencies Framework was introduced in 2005, and refreshed in 2011, to ensure an adequate framework was in place to allow public service organisations to properly respond to emergencies. The DoE issued Guidance to Councils in Relation to Emergencies provided Councils with a policy and legislative framework in which to undertake emergency planning, set out their powers in relation to emergencies, and identified Chief Executives as responsible for their Council's emergency planning.

Due to an increased frequency of emergencies, the Northern Ireland Executive agreed, in 2014, to put in place enhanced civil contingency arrangements. A new structure of Emergency Preparedness Groups (the "EPGs") was put in place, with Councils playing an important role in supporting and facilitating the administrative function of three EPGs.

In May 2018, councils endorsed a new local government resourcing model for the civil contingencies function and a regional service, hosted by a single Council that would employ all Officers was agreed. Armagh City, Banbridge and

Craigavon Borough Council act as Lead Council on the basis of an agreed SLA with the 10 Councils.

Three other Councils act as host Councils for the function. Further to ES190205 and CM190226 Causeway Coast and Glens Borough Council, acts as host Council for the Northern EPG and agreement to clause 3.2 of the reviewed SLA is sought for this arrangement to continue.

The SLA, attached at appendix 1 to the previously circulated report, has been updated with the following substantive amendments.

- Clause 5.1 clarifies the role of the Local Government Resilience Team as independent of each District Council and decision making lies with Councils.
- Clause 5.4 The Department for Communities (DfC) agrees to fund the function and will give Councils at least 6 months' notice if funding is to be withdrawn. In the event funding is withdrawn, DfC will meet residual severance costs of staff employed.

<u>Update on key priorities of the Local Government Regional Resilience</u> Function

<u>Covid-19 Inquiry -</u> The regional team has worked with NILGA and legal services to prepare and collate local government responses for Module 1 and Module 2c of the Inquiry. The team have also worked with local government and PSNI preparing a submission on behalf of the NI Emergency Preparedness Groups and sub regional Emergency Preparedness groups.

<u>Martyn's Law</u> (formerly referred to as Protect Duty) has the aim of making the public safer at publicly accessible locations. Consultation took place in 2021 and the resultant Terrorism (Protection of Premises) Draft Bill entered prelegislative scrutiny on 2nd May 2023. The draft bill is high level with the detail to be contained in secondary legislation and statutory guidance. No legislative approval will be required by the Devolved Administrations.

N.I. focused workshops on Martyn's Law took place in May 2023 and concerns were raised on the application of the approach in N.I. There is no indication regarding the regulation/enforcement model yet but suggestions include a new independent arm's length body. Implementation could be in 3-6 years. The Executive Office have agreed to convene a meeting with the Home Office, Department of Justice and local government to discuss the concerns raised from an N.I. perspective.

The following Regional Partnership Arrangements are due for update and will be brought before Councils in due course:

- Council and DAERA Epizootic Disease Memorandum: existing agreement to assist DAERA in the event of a large-scale epizootic outbreak.
- Local Government and NIHE Call Off Contract Arrangements: existing
 agreement where NIHE contractors can be utilised in the response of a large
 scale flooding or other weather event and expenditure incurred can be
 reimbursed via the DFC Scheme of Emergency Financial Assistance.

7. FUNDING OFFER FROM DEPARTMENT OF BUSINESS ENERGY & INDUSTRIAL STRATEGY (BEIS) 2023-2024

Report, previously circulated, was presented by the Director of Environmental Services.

Purpose of Report

(BEIS) up to the value of £55,000.

Background

The Office for Product Safety and Standards (OPSS) is the national regulator for product safety and is part of BEIS. It was established to lead and coordinate the UK product safety system to deliver improved protections for consumers and better support for industry across the UK. It is responsible for developing and building national capacity and capability for product safety that is consistent and applied uniformly across the UK.

Correspondence was received from BEIS on the 21st June 2023 offering a grant to support Council to build capacity and capability to ensure the safety of consumers. The grant is to fund targeted and prioritised regulatory activity on non-food consumer products as part of BEIS' approach to ensure robust market surveillance across the UK.

Council has been offered a grant of up to £55,000 for expenditure incurred between 1st April 2023 and 31st March 2024. A copy of the grant offer is attached as Appendix 1 to the previously circulated report.

Reporting Arrangements are expected to include inputs to relevant databases; quarterly submission of records of activity (format to be agreed); and a review meeting at the end of the grant funding year. OPSS may seek information about operational methods, activities, engagement with businesses and outcomes.

This funding would support Council's statutory responsibilities under Consumer Safety legislation.

8. CONSIDERATION OF PROPOSED DOG CONTROL ORDER TO KEEP DOGS ON LEADS ON LANDS BETWEEN BALLINTOY AND WHITEPARK BAY – FINDINGS OF PUBLIC CONSULTATION

Report, previously circulated, was presented by the Director of Environmental Services.

Purpose of Report

The purpose of this report is for members to consider the responses to a public consultation and make a decision on a proposed Dog Control Order requiring dogs to be kept on leads between Ballintoy Harbour and Whitepark Bay.

Background

Environmental Services received a request to impose a Dog Control Order on lands where an asserted Right of Way path runs from Ballintoy Harbour to

Whitepark Bay. The lands in question are private lands where livestock are kept however the public use the pathway for recreation and for walking dogs.

The landowner claims that members of the public do not exercise proper control of their dogs by keeping them on a leash and as such the landowner has suffered loss due to dogs worrying the livestock.

Further to CM220630 it was decided that Council would progress the procedure to introduce a Dog Control Order to exclude dogs from these lands which included a public consultation on the proposal.

A public consultation was launched on 3rd January 2023. A total of 151 responses were received with 147 letters of objection and 4 letters of support.

Council considered the results of the public consultation and further to ES230216 and CM230307 decided to progress with the procedure to introduce an alternative Dog Control Order whereby dogs would not be excluded from the area but instead must be kept on a lead at all times whether livestock are present or not. In accordance with procedure this option required a further public consultation to be undertaken the results of which are detailed in 7.0.

Existing Legislative Provisions

Legislative provisions to control dogs on land where livestock is kept exist within the Dogs (NI) Order 1983. Regulation 25 of this Order requires anyone with a dog on land where livestock is kept to keep that dog under control by means of a leash. Any person who contravenes this regulation shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding £200.

Regulation 28 of the Dogs (NI) Order 1983 states that if a dog worries livestock, or attacks and injures any other animal owned by another person, the keeper of the dog and the person in charge of the dog shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 3 (£1,000) on the standard scale.

Power to make Dog Control Orders

Under Part 5 Article 40 of the Clean Neighbourhoods and Environment Act (NI) 2011 a district council may make an order providing for an offence or offences relating to the control of dogs in respect of any land in its district to which this Part applies. An order under this subsection shall be known as a "dog control order".

Although the land in question here is private land used to keep livestock, the power to make a Dog Control Order applies as it is land to which the public are entitled to access due to the asserted Right of Way path.

Considerations of imposing a Dog Control Order

The Department of the Environment (NI) produced guidance for District Councils to refer to when considering imposing Dog Control Orders called 'Guidance on Part 5 of the Clean Neighbourhoods and Environment Act

The following excerpts are from that guidance on general principles:

- Paragraph 1.3 District councils may make dog control orders, provided that they
 are satisfied that an order is justified, and they have followed the necessary
 procedures.
- Paragraph 1.5 However, enforcement of the legislation is just one tool that is available to district councils to deal with dogs. Councils should bear in mind that the introduction of a dog control order may not always be the most appropriate course of action and that education also has an important part to play in promoting responsible dog ownership.
- Paragraph 2.2 The council needs to balance the interests of those in charge of dogs against the interests of those affected by the activities of dogs, bearing in mind the need for people, in particular children, to have access to dog-free areas and areas where dogs are kept under strict control, and the need for those in charge of dogs to have access to areas where they can exercise their dogs without undue restrictions. A failure to give due consideration to these factors could make any subsequent dog control order vulnerable to challenge in the Courts.
- Paragraph 2.3 District councils should also consider how easy a dog control order would be to enforce, since failure to enforce properly could undermine the effect of an order. This is particularly the case for orders that exclude dogs completely from areas of land.

Outcome of Monitoring Visits

To assess the situation monitoring of the area was carried out by officers from the Enforcement team. For an offence to be committed under Regulation 25 of the Dogs (NI) Order 1983 livestock must be present on the land in question and dogs must be off leash and not under control.

Monitoring was carried during the week and at weekends between 31st January to 22nd February 2022 and found:

- Of the 37 visits livestock was present 5 times
- Of the 37 visits dogs were observed not under control 6 times
- Of the 37 visits no offences were detected whereby livestock was present and dogs were off leash

Monitoring was carried out on weekdays from 29th April 2022 to 27th May 2022 and found:

- Of the 10 visits livestock was present once
- Of the 10 visits dogs were observed not under control once
- Of the 10 visits no offences were detected whereby livestock was present and dogs were off leash

Monitoring was carried out from 16th January 2023 to 30th January 2023 and found:

- Of the 10 visits livestock were present 8 times
- Of the 10 visits dogs were noted 6 times when livestock was present
- On one occasion dogs were noted off leash while livestock were present when a dog owner was observed entering the area from Whitepark Bay with 2 retriever dogs off leash. When approached by the Environmental Warden and advised of the presence of livestock the owner leashed the dogs.

In total the Enforcement Team have carried out 57 monitoring visits since between January 2022 and January 2023 and on one occasion noted dogs off leash when livestock were present.

An elected member visited the area on two occasions and reported the following:

- 14th April 2022 3 walkers with dogs off leads and livestock present. 1 dog observed making an attempt to chase but was restrained by the owner.
- 3rd May 2022 No dog walkers observed.

Environmental Services engaged with the person who made the request for the Dog Control Order to provide a written witness statement indicating the extent of the problem in their experience and to provide supplementary evidence to support any losses incurred such as veterinary records.

The complainant provided a witness statement confirming their general complaint of the land being used by dog owners but there are no specific details of number of incidents of dogs attacking livestock, no details of numbers of livestock lost and no veterinary evidence of treatment of livestock following dog attacks.

Results of Public Consultation

Before making an Order the Dog Control Orders (Procedures) Regulations (N.I.) 2012 require a Council to publish a notice describing the proposed order on its website and in a local newspaper and invite representations on the proposal.

At the end of the consultation period Council must consider any representations made. If Council decides to proceed with the order, it must decide when the order will come into force. This must be at least 14 days from the date on which it was made.

The public consultation on the proposal to introduce a Dog Control Order requiring dogs to be kept on a lead at all times whether livestock are present or not, on the lands between Ballintoy Harbour and Whitepark Bay, was launched on 28th June 2023.

A total of 5 responses were received, 3 letters of objection and 2 letters of support (Appendix 1, circulated).

Considerations for Council

- There already exists legislation whereby dogs must be under control by means of a leash on lands where livestock is present.
- The relevant guidance requires that the introduction of any Dog Control Order must be justified.
- Councils must take into account the interests of dog owners to be able to exercise their dogs without undue restrictions.
- Any proposed Dog Control Order must have a public consultation and the responses from this consultation such as objections to the Dog Control Order must be considered.
- The introduction of any Dog Control Order is subject to legal challenge and may fail if Council cannot demonstrate that such an Order is required and justified.
- The Environmental Health Department have no recorded complaints of any incidents of dogs worrying livestock on these lands.
- From the total of 57 monitoring visits undertaken by the Enforcement Team a relevant offence was detected on one occasion which was resolved by the dog owner following advice from the Environmental Warden.
- From 2 visits undertaken by an elected member, 3 dogs were observed off lead while livestock present.
- The witness statement by the complainant does not provide any supporting evidence in relation to the complaint.

Options

Option 1 - Council does not proceed with the introduction of a Dog Control Order to require dogs to be kept on a lead at all times and continues to rely on enforcement of existing legislative provisions under the Dogs (NI) Order 1983 which require dogs to be kept under control by means of a leash where livestock are present.

Option 2 – Proceed with introducing new legislation in the form of a Dog Control Order (Dogs on Leads) to require dogs to be kept on a lead at all times on the lands between Ballintoy Harbour and Whitepark Bay whether livestock are present or not.

Recommendation

It is recommended that members of the Environmental Services Committee make a recommendation to Council that Council does not introduce a Dog Control Order requiring dogs to be kept on a lead at all times on lands between Ballintoy Harbour and Whitepark Bay and relies on existing legislative provisions (Option 1).

Councillor MA McKillop queried whether the consultation response box had been collected from Sheskburn House, as she noticed it was still there last week. She expressed concern that some responses may not have been included in the report on this matter, as that would be the box where you would expect most responses.

The Director of Environmental Services stated that his understanding is that all consultation responses were collected and form part of what is included in the report.

The Temporary Head of Health and Built Environment advised that all forms should have been collected from Sheskburn, but that she would double-check that that is the case.

Councillor MA McKillop requested that this be double-checked in advance of the next Council meeting.

Alderman Hunter proposed that the Committee supports Option 2 rather than the recommendation made to the Council. She stated that a Dog Control Order should be introduced, as you cannot see the full field on entering the piece of land, therefore a dog owner cannot be sure that there is no livestock present.

Councillor Wallace suggested that, given the query around whether all consultation responses have been seen, the decision be deferred until the full Council meeting.

Alderman Hunter stated that she was happy to defer the decision.

Councillor Kane stated that he was happy to defer the decision. Councillor Kane requested more information on the thought process leading to the recommendation to Committee to not go ahead with the Dog Control Order. He asked what is in place to inform the public of the existing legislation.

The Director of Environmental Services referred Councillor Kane to paragraphs 3.1 and 3.2 of the report on this matter, which state:

Legislative provisions to control dogs on land where livestock is kept exist within the Dogs (NI) Order 1983. Regulation 25 of this Order requires anyone with a dog on land where livestock is kept to keep that dog under control by means of a leash. Any person who contravenes this regulation shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding £200.

Regulation 28 of the Dogs (NI) Order 1983 states that if a dog worries livestock, or attacks and injures any other animal owned by another person, the keeper of the dog and the person in charge of the dog shall be guilty of an offence and liable on summary conviction to a fine not exceeding level 3 (£1,000) on the standard scale.

The Director of Environmental Services advised that signage is in place at Ballintoy and Whitepark Bay to advise of the legislation and, as such, dog

owners are advised to keep their dog on a leash when there is livestock present.

AGREED – to recommend that Council defers a decision on the introduction of a Dog Control Order requiring dogs to be kept on a lead at all times on lands between Ballintoy Harbour and Whitepark Bay until the next Council meeting.

10. REMEDIAL WORKS AND REPAIRS AT CRAIGAHULLIAR LANDFILL SITE

Report, previously circulated, was presented by the Director of Environmental Services.

Purpose of Report

The purpose of this report is to seek approval from members to carry out essential remedial works and repairs at Craigahulliar landfill site.

Background

Craigahulliar Landfill Site occupies a quarry, which operated until 1989, and is located on Ballymacrea Road, approximately 2.75km to southeast of Portrush, Co. Antrim.

The site operates as a non-hazardous landfill and is permitted to accept up to 90,000 tonnes of waste per year. The site covers an area of approximately 176,000 square metres.

The site operates under a PPC Permit and is inspected by the Northern Ireland Environmental Agency (NIEA) to ensure compliance with applicable statutory obligations and requirements.

Council submits an annual Craigahulliar Landfill Environment Report to the NIEA.

Proposal

Following an external review of current site operations, a number of works have been identified to bring the site within the terms of its NIEA Permit. Works identified are also to ensure that the appropriate site health and safety requirements are adhered to and enhanced where necessary.

Works identified as needing completed can be found in appendix 1 to the previously circulated report.

Options

Do nothing. If repair works identified are not expedited the site will not comply with NIEA Permit. As a consequence, the site may be temporarily closed until the appropriate remedial actions are taken.

Carry out remedial works and repairs as identified to ensure continued compliance with NIEA Permit, maintain appropriate health and safety standards and avoid disruption to day-to-day operations at site.

Recommendation

It is recommended that the Environmental Services Committee recommends to Council that essential remedial works and repairs identified following an external review are carried out so as to ensure the site

continues to meet its statutory obligations and health and safety is not compromised.

The Director of Environmental Services drew Members' attention in particular to the tank replacement that is required. He advised that the existing tank is not fit for purpose and may need imminent intervention.

Councillor Wallace stated that there did not appear to be many options, and that the work needs to go ahead to ensure the health and safety of the public and of Council staff. He also queried the status of remedial work at Crosstagherty.

The Director of Environmental Services advised that a proposal would be coming in the October meeting regarding the remedial works at Crosstagherty.

AGREED – to recommend to Council that essential remedial works and repairs identified following an external review are carried out so as to ensure the site continues to meet its statutory obligations and health and safety is not compromised.

11. CONCESSIONARY TRADING POINT - PAYMENT REBATE

Report, previously circulated, was presented by the Director of Environmental Services.

Purpose of Report

To allow members to consider a recommendation of the NI Public Sector Ombudsman (NIPSO) to rebate the licensee on Councils concessionary trading site at West Bay Portrush and to provide authorisation to make such a payment - see appendix 1 recommendation 59 (i) (circulated).

Background

Following an auction of Councils concessionary trading sites (March 2021) A complaint was made by the successful bidder of the concessionary trading site at West Bay.

Having exhausted Councils complaint process the complainant subsequently referred the complaint to the NIPSO.

The new licensee / successful bidder raised a complaint that Council removed the application criteria requirements originally stipulated in the application form to participate in an online auction to tender for licences to trade on Council concessionary sites and that this was altered after the process had commenced, without informing existing registrants. As a result, the complainant said the application process was unfair and disadvantaged them and those who did meet all the original application criteria.

To provide some context, officers received a plethora of enquiries from members of the public who wished to be able to participate in the auction for an outdoor concessionary trading site but currently did not have a trading receptacle. They wished to attempt to enter the outdoor catering market during a period of uncertainty due to covid restrictions which impacted indoor venues and felt they were being discriminated against and the auction was a 'closed shop.' They wished to secure a site from which to trade from first before purchasing a receptacle.

A decision was therefore taken within the department to open the auction up to those who did not have a trading receptacle. This decision was taken in an attempt to achieve best value for our assets in line with NI Audit guidelines. Due to time constraints/deadlines to ensure continuity of trading, a notice could not be placed in local media outlets prior to the date of the auction. Note: this only affected one trading site.

The findings and recommendations from NIPSO are attached at Appendix A of the previously circulated report.

Proposals

- 1. To accept the recommendation 59 (i) within the NIPSO report and refund the overpayments to date over and above the yearly licence fee of £7,800 plus vat and to charge the remainder of the licence period at this amount. This equates to £6,700 plus vat per annum for year 1 (2021/22) and year 2 (2022/23). Year 3 (2023/24) is £550 plus vat based on payments already made. Total refund of £13,950 plus VAT.
- 2. Commission and independent review of the approach taken in the procurement exercise as recommendation 59 (ii)
- 3. Note all other recommendations within the NIPSO report shall be addressed by officers items 58 to 61)

Recommendation

It is recommended Members consider the findings of the NIPSO report and authorise officers to rebate the overpayments.

The Director of Environmental Services advised Elected Members that the Council's Chief Executive has already accepted the findings of the report and has issued an apology to the complainant on behalf of the Council.

Councillor Kane queried whether the recommendations from the NIPSO report regarding the commissioning of a review and undertaking recommended training have been implemented.

The Director of Environmental Services advised that this was in process. He advised that the internal auditor is carrying out an internal review, and there will be an external investigation. He advised that a Procurement Officer is now in post. The Procurement Officer is sourcing the relevant training. He advised that all future matters relating to concessionary trading tender will go through the Procurement Officer.

Summary

Keep Recycling Local (KRL) consultant is seeking an opportunity to present to the Environmental Services Committee.

KRL is a recently launched campaign group created to help raise awareness about recycling in Northern Ireland. Their aim is to ensure that the recyclable materials collected here are also processed in Northern Ireland, to aid the circular economy and benefit our environment.

With the upcoming statutory guidance changes expected to have an impact on how collections are managed, and ahead of the upcoming DAERA consultation, they would appreciate the opportunity to present to members of the Council's Environment Committee at the earliest convenience (post July) to outline the benefits associated with keeping recycling local.

Given the potential savings for Councils, and that this is a core Council service provision, it might also be helpful for officials from the Chief Executive's Office and Finance Directorate to attend. Equally, they would be more than happy to speak with them separately.

Recommendation

It is recommended that the Environmental Services Committee consider the correspondence.

Alderman S McKillop stated that this is a very important issue and that recycling locally has the potential for great savings. Councillor McShane spoke to her proposal. She stated that if the Committee were content to support the motion, it could be possible to apply to the Department for Communities Access and Inclusion Programme for funding. The 2023/24 programme opens in November 2023 and closes in December 2023, so it is a short window for application.

Councillor McShane stated that the existing harbour toilets are a potential location for the proposed Changing Places facility.

Councillor McShane also proposed that the Council could look at ways to modify access to the beach on Rathlin Island to enhance accessibility, similar to the boardwalk access in Ballycastle. This could link from the Changing Places facility.

Councillor McShane stated that, as Council's Diversity Champion, she welcomes the various positive initiatives that the Council has been involved in to date, including partnership working with other bodies such as Mae Murray Foundation to enhance access to our beaches such as Benone.

Councillor McShane proposed that the Council could look at the provision of portable hoists to give greater access for people with disabilities to use boats and pontoons. She stated that such an initiative could allow the Rathlin Sound Maritime Festival to become more inclusive and allow Sailability Foyle to run events.

Councillor McShane stated that she wished to amend the motion to include these additional points, with the amended motion to read as follows:

- "That this Council explores options to build a Changing Places facility on Rathlin Island and further recognises the importance of Changing Places toilets in delivering our vision of an accessible and inclusive Causeway Coast and Glens. Councillor Watson stated that Changing Places Facilities are located across many council areas, but there is currently no adequate accessible toilet/changing facilities for our only island community.

"This Council is concerned by the recent blooms of blue-green algae in our waters; notes the detrimental impact these blooms have had on local businesses; asks the Department of Agriculture, Environment and Rural Affairs to swiftly convene a cross party meeting between affected Council areas to discuss the issue & to develop an action plan to address it; and calls for the establishment of an independent Environmental Protection Agency in line with New Decade, New Approach commitments."

Councillor McCully spoke to his motion, stating:

 Anyone who has been paying attention to the news this summer will know just how severe the blue-green algal blooms are in Lough Neagh & other local water bodies.

- The algae bloom is so bad that the water is effectively sludge in places. This is having a severe impact on the Lough's biodiversity, with reports of birds dying; fish kills & the disappearance of the Lough Neagh fly.
- The problem of blue-green algae is not confined to Lough Neagh. Blue-green algae has been confirmed to be present in a range of different water bodies this summer this is why the Department of Agriculture, Environment and Rural Affairs (DAERA) action plan is required to address it.
- The quality of the water in the River Bann has been badly affected. Blooms have been reported all along the river. A watersports business in Kilrea has been forced to close. Algae detected near to our beaches has forced them to close until levels reduce.
- The problem is out of control and the response from DAERA and the Northern Ireland Environment Agency has not been sufficient.
- This is a complex problem with many causes. DAERA has confirmed that
 the algae blooms are mostly the result of invasive species altering the local
 biodiversity; in addition to agricultural run-off, and climate change raising
 the temperature of the waters.
- The ownership of the Lough further complicates matters, as DAERA or Dfl currently do not own the water. The question of whether the Lough should be brought into public ownership could take years to resolve. However, we need immediate action to prevent a repeat of the disruption experienced this summer.
- The blue-green algae has resulted in disruption to businesses: a watersports business in Kilrea has had to close due to the blooms making it impossible to trade; in Coleraine, another watersports business has had to ban customers from using their own wetsuits. In Causeway, we have had to close beaches during the high season. This has a knock-on impact on businesses reliant on customers visiting the beach.
- Our Council spends a significant amount of resource and time promoting our seaside towns to visitors. These algal blooms and wider water quality issues threaten to undermine all this positive work.
- The information provided to Councillors from DAERA & the Northern Ireland Environment Agency has not been sufficient. We need a direct line of communication between elected representatives and department officials.
- Many of the problems we are currently seeing in Lough Neagh and further afield could be addressed by establishing a truly Independent Environment Protection Agency (EPA). Currently, the NIEA does not have strong enough enforcement powers to hold DAERA, NI Water and private entities

to account. This disaster unfolding in front of us is a clear example of why an Independent EPA is so badly needed. Northern Ireland remains the only area in the UK & Europe without one.

 Commitments to establish an Independent EPA were included in the New Decade, New Approach deal which was signed by the 5 main parties. It is long past time that DAERA makes moves to establish this body.

Alderman Stewart stated that he is happy to second the motion. He stated that this is a worrying situation that is having a devastating impact on Lough Neagh and its surrounding wildlife, as well as businesses.

Alderman S McKillop stated that she would not disagree with what has been said, but she would not support the creation of an Independent Environment Protection Agency, as we already have multiple layers of government, including departments, agencies and councils.

Alderman S McKillop stated that Council need to tackle pollution in the hotspot areas using targeted policies, capital support and more meaningful enforcement action. She stated that Council need to focus on actions and outcomes rather than wasting time on setting up new structures and governance.

Amendment

Proposed by Alderman S McKillop Seconded by Alderman Knight-McQuillan

"This Council is concerned by the recent blooms of blue-green algae in our waters; notes the detrimental impact these blooms have had on local businesses; asks the Department of Agriculture, Environment and Rural Affairs to swiftly convene a cross party meeting between affected Council areas to discuss the issue & to develop an action plan to address it; and calls for the establishment of an independent Environmental Protection Agency in line with New Decade, New Approach commitments."

Councillor Bateson stated that he had asked to speak prior to Alderman S McKillop and that he wished to propose an amendment.

The Chairperson advised that he was not aware of that. The Chair ruled that there would be a vote on Alderman S McKillop's amendment, and that Councillor Bateson could propose a further amendment should Alderman S McKillop's not pass.

Councillor Bateson stated:

- Sinn Féin has been in repeated contact with the NIEA on the occurrences of toxic algae including in the sea at Castlerock, Portstewart, Benone and Downhill as well as the significant issues that have occurred recently in Lough Neagh.
- The occurrences of toxic algae this summer are obviously very concerning from an environmental perspective.

- Additionally, the algal blooms occurred on the north coast at the busiest time
 of the year for tourism, which is when many local businesses make the most
 of their annual income, and therefore has had a detrimental impact on local
 businesses.
- Dealing with the toxic algae requires all the agencies with responsibilities to cooperate to address the issues causing it.
- The occurrence of the toxic algae in the River Bann and along the north coast are believed to have originated from Lough Neagh and travelled along the river, therefore tackling it at that source is key.
- Sinn Féin has long advocated for Lough Neagh to be brought into public ownership; long before this latest algae bloom, we had brought motions to both the Assembly and councils calling for just this.
- Given that Lough Neagh provides more than 40% of the north's drinking water, the recent proliferation of blue-green algae is rapidly making management of the lough a public health issue.
- The lough should be brought under public ownership so that a clear management structure can be developed and long-term plans made for dealing with the numerous issues that face the lough, from biodiversity and sustainability to navigational markers and promotional marketing.
- In developing a management structure, it would also be prudent to include the views and expertise of those who know and love the lough best; the communities that live beside it and those who make their living on it.
- In addition to undoing the damage that has been done to the lough, there is tremendous environmental, economic and tourism potential in the lough, if it is managed properly.

Councillor Kane stated that he wished to propose the substantive motion. He said that this matter needs urgent action. He advised that the creation of an Independent Environmental Protection Agency is not a new proposal, as it was agreed to over three years ago but has not yet been implemented. He stated that we need a body that is independent and has the power to take action when required to prevent this recurring.

Councillor Mairs stated that she wished to second Councillor Kane's proposal of the substantive motion.


