#### 3.0 The Annual Meeting 2024

In accordance with Council's Standing Orders, 1 (1) In every year that is not a local election year the Council shall hold an Annual Meeting in the month of June.

It is proposed that Council shall hold its Annual Meeting on **Monday 3<sup>rd</sup> June 2024 at 7.00pm.** 

#### 4.0 Rate Strike Meeting 2025

Councils are legally required to strike the rate no later than 15<sup>th</sup> February each year.

It is proposed that Council shall hold its Rate Strike Meeting on **Thursday 6**<sup>th</sup> **February 2025 at 7pm.** It is further proposed that Council shall hold Thursday 13<sup>th</sup> February 2025 at 7pm, in the event of allowing time for any potential adjournment and enable Council to strike within the appointed timeframe.
