The new retaining wall shall be of a cantilever form with heel (horizontal) & stem (vertical).

LA01/2018/0016/F	Cushendall Bay, Cushendall. (S of the River Dall).	Upgrade of circa 59m of existing coastal defences extending S from the River Dall. Works to include sheet piling (to tie into the existing River Dall footbridge piled abutment) & precast concrete retaining wall sections with in-situ concrete stitches. The construction of the embankment behind the wall will comprise geosynthetic erosion control matting & will be planted with native grass species.
