3. Applicants must spend at least £50 on washable nappies, inserts, cloth wipes and nappy buckets to be eligible for a voucher worth £30 or £80 for a voucher worth £60.
4. The voucher can be redeemed through Babame - <https://www.babame.com/> and cannot be paid without the original, itemised receipts(s) which include date of purchase
5. Vouchers are available for purchases from 1<sup>st</sup> August 2018 onwards (must have receipt).
6. Participation in the voucher scheme is considered to be a 'one off' and does not constitute any commitment to future support.
7. A voucher will be arranged on a first come, first served basis.
8. Only one voucher application per household will be accepted.
9. Causeway Coast and Glens Borough Council will ask you to provide feedback.
10. The scheme is subject to availability and may be withdrawn at any time.
