	<p>The proposal relates to implementation of Directive 2013/59/EURATOM laying down basic safety standards for protection against the dangers arising from exposure to ionising radiation (BSSD). The BSSD lays down minimum radiation safety standards for three different exposure groups: medical patients, workers and members of the public. 	Department of Health	The Fire and Rescue Services (Northern Ireland) Order 2006 Amendment	3 June 2018
<p>The Department of Health proposed to make amendments to the Fire and Rescue Service (NI) Order 2006 and seeks the views of Council on the proposals.</p> <p>NIFRS identified the potential for a fire safety risk in the 2006 Order. As currently worded the Order removes responsibility for fire safety inspection and enforcement in common areas that exist in flats and apartment blocks. The department proposed to make NIFRS responsible for fire safety inspection and enforcement in common areas of domestic premises such as flats and apartment blocks. The Order will be amended to allow the Chief Fire and Rescue Officer to delegate fire safety inspection for relevant premises rather than just workplaces. This will allow the Chief Fire and Rescue Officer to delegate responsibility for fire safety inspection in homes of multiple occupancy (HMO's) to local Councils. <p>On March 2018, the Department for Business, Energy and Industrial Strategy (BEIS) launched a consultation which put forward a number of measures to improve corporate governance in firms that are in or approaching insolvency. 	DAERA	Implementation of the new Animal Breeding Regulation	11 July 2018
	<p>A new single EU Animal Breeding (or zotech) Regulation ((EU) 2016/1012) entered into force on 19 July 2016. DAERA is required to facilitate the implementation of the Council Regulation (and the associated implementing regulations) into domestic legislation on, or before the 1 November 2018.</p> <p>Currently, zotechnical activity is governed by separate regulations listed by species covering cattle, pigs, sheep and goats, equines and their germinal products. The purpose of EU zotech rules are to facilitate trade in pedigree breeding animals, hybrid breeding pigs and germinal products throughout the EU, whilst protecting genetic diversity.</p> <p>Together, the suite of existing regulations provide a mechanism for breed societies to be 'officially recognised' by the relevant competent authority. Official recognition then provides breed societies with certain legal rights and obligations and approval is conferred, subject to meeting and adhering to certain eligibility criteria. DEFRA oversees the approval of breed societies in England, whilst responsibility for this function in the rest of the UK lies with the devolved administrations in Scotland, Wales, and DAERA in Northern Ireland.</p>
