	<p>The Commission is seeking views on action it proposes to take when the accounts and reports of registered charities fail basic compliance testing.</p> <p>Basic compliance checks are carried out on annual monitoring returns (AMRs) submitted by registered charities under the <a href="#">Annual reporting</a> programme. The aim is to ensure that the information submitted complies with the fundamental requirements of charities legislation. When an AMR fails a basic compliance check the Commission contacts the charity trustees to advise where they have not complied with their legal obligations and to provide regulatory advice.</p> <p>In order to improve compliance levels and keep the public informed, the Commission proposes indicating on a charity’s register entry whether they have been subject to a basic compliance check. Any charity which fails a basic compliance</p>		

	<p>check will be provided with guidance by the Commission. Where a charity fails to comply with the regulatory guidance provided, the Commission proposes to change the entry on the <i>register of charities</i> to read: <b>Failed</b>.</p> <p>The consultation is seeking your views proposals.</p> <ol style="list-style-type: none"> <li>1.
