Antrim		B2	An important surviving grouping comprising a former jail and adjacent former listed Court house (HB04.15.002). Although converted into a police station in the 20th century, the core of the original c1830 jail building and its former 'keeper's house' are clearly identifiable and considerable original building fabric remains. The 1920's conversion involved adding some good architectural details, most notable a fine Art Deco full height open newel type staircase. Generally the complex with its adjacent court house, are of considerable social importance, having played a significant role in the lives of 19th century Ballymoney.	1820-1839

HB04/15/002	22/13NW	C9450 2569	Court House and walling 75 Charlotte Street Townparks Ballymoney Co Antrim		B1	An elegant, well proportioned and detailed one and two store former courthouse, built c1830, to the designs of the important architect Charles Lanyon. It played an important role in the history of Ballymoney for over 130 years and also forms part of a group with the adjoining jail (HB04.15.001) ; it is rare in Ireland that adjoining court houses and jails have survived.	1820-1839
