



Play it Safe this Halloween

Halloween might be a few weeks away yet, but this can be a busy time for police and other emergency services and it is not uncommon to see increased reports of criminal damage and calls in relation to anti-social behaviour. Most people are responsible, but we need to be considerate and mindful of others when it comes to marking the Halloween festivities and bear in mind the current guidelines and regulations relating to Covid-19.

Parents need to make sure they know the whereabouts of their children and to make sure that they are not

engaging in any criminal activity or criminal damage to property. Individuals are also being urged to pay close attention to their own personal safety if they intend to be in the vicinity of fireworks, sparklers or bonfires. Fireworks contain explosive, flammable substances, which can cause serious injury to an individual or damage to property. Children using sparklers should also be closely supervised.

The safety advice below can help make Halloween a safe, enjoyable time for everyone.

FIREWORKS AND SPARKLERS

- Fireworks require a licence - except indoor fireworks and sparklers.
- It is illegal to possess, purchase, sell, handle or use fireworks except under licence.
- Only adults should light or handle fireworks.
- Never ever go back to a firework once lit - even if it does not go off.
- When watching fireworks, stand well back.
- It is an offence to throw fireworks in the street or other public places.
- Always supervise children around fireworks.
- Never give sparklers to children under the age of five.
- Light sparklers one at a time and always wear gloves.
- Keep a bucket of water close by and put sparklers in it when they go out.
- You can be fined up to £5,000 for breaking the law in relation to fireworks.

The law clearly states that fireworks must be bought from a licensed dealer who is required to keep sales records. Fireworks bought from other sources could be of a sub-standard quality, with the potential to cause serious injury.

- **Fireworks that do not have instructions printed in English are ILLEGAL.**
- **All bangers are ILLEGAL.**
- **The purchase, possession or use of fireworks without a licence is an OFFENCE.**

We would also appeal to the community to help us stamp out illegal trading and misuse of fireworks by contacting local police on 101. MAKE UNI DAYS THE BEST DAYS

If you are a parent or guardian with a son or daughter at university you might want to consider sharing with them the following advice.

For some students, this will be the first time they will be living away from home however with this new found freedom comes responsibility. A responsibility to keep themselves and their belongings safe, a responsibility to get on with their neighbours, and a responsibility to get home safe at the end of the evening.

Encourage them to arrange transport home in advance when planning a night out. Ask them to stick with their mates, and to avoid drinking to the

point where they are incapable of looking after themselves.

Encourage your son or daughter to show respect for their neighbours and to recognise the negative impact drunken, noisy and irresponsible behaviour could have for residential communities.

Finally reassure them that wherever they go there are support services available on campus to help them out in those first weeks and throughout the university term.

BEAT THE BURGLAR

The darker evenings can often act as a cover for criminals who are intent on making off with your personal possessions.

Crime Prevention Officer Judith Lavery explains some of the simple steps you can take to make your home safer this autumn.


"Don't make it easy for anyone to get access to your home. The simplest step you can take is to make sure doors and windows are closed and locked. So many burglaries happen because the criminal was able to walk in through an unlocked door or climb through an open window and the first you know about it is when you wake up in the morning or return home to find your TV, laptop, tablet or wallet is missing.

"Before you leave the house run through this checklist:

- **Did I lock all the doors?**
- **Did I close and lock all the windows?**
- **Is the garage door secure?**
- **Did I leave a light on?**
- **If I go out will the house look unoccupied?**
- **Can valuable items be seen through the windows?**
- **Should I close the blinds/curtains or ask a neighbour to keep an eye on my house?**
- **Did I set the house alarm?**

"All valuables, including jewellery, should be permanently marked with the house number and postcode so that items will be more difficult to sell. Jewellery should be properly valued and itemised for insurance purposes, photographed against ruler for easy identification, and placed in a safe that is secured to the fabric of the building.

"If you are out shopping in the car, anything valuable should be kept in the boot or out of sight of passers-by. Make these home security steps part of your everyday routine and you will significantly reduce the chances of becoming a burglary victim."



TECHNOLOGY TO BEAT THE CAR THIEF

Being the victim of vehicle theft can be costly, therefore you want to take every precaution to ensure your mode of transport is well protected. More and more manufacturers these days are using apps that enable the car owner to perform certain functions remotely, including locating and immobilising the vehicle. It could be worth checking with your dealership or manufacturer to see if there is an app available for your vehicle. Should the worst happen, you might just increase your chances of getting your car back.

Our RAPID Bin scheme stands for the Removal of All Prescription and Illegal Drugs and is run in partnership with the local PSNI and PCSP teams. Your local bins are located in CRUN Coleraine and LCDI Limavady.



June 2020 saw our Alcohol Awareness Campaign, and the Northern team had to adapt our original plans due to lockdown. We came together with the other Regional Connections Teams and worked on putting together a strong social media campaign and creating an Alcohol Awareness Raising video. The PHA NIAAW posts reached over 25,500 on Facebook, and social media and our blog article reached over 24,600 & the Awareness video reached over 5,275 people.
