POLICING AND COMMUNITY SAFETY PARTNERSHIP

Causeway Coast and Glens PCSP, established under the Justice Act (Northern Ireland) 2011, has the overall purpose of helping to make communities safer and to ensure that the voices of local people are heard on policing and community safety issues. The aim is to empower communities to help develop solutions that will help tackle crime, fear of crime and anti-social behaviour.

Strategic objectives for Causeway Coast and Glens Policing and Community Safety Partnerships are as follows:

Strategic Objective 1 – to successfully deliver the functions of the Policing and Community Safety Partnership for the area by:

- Engaging with local community and statutory groups, to identify local concerns in relation to
 policing and community safety, and to invite their contribution to prioritising and addressing
 those concerns;
- Preparing the PCSP's plan, and organising the work of the partnership to meet priority needs;
- Putting in place implementation structures and delivery mechanisms that will contribute to a reduction in crime and the enhancement of policing and community safety in the area, directly through the collaborative working of the membership of the Partnership, through the work of its delivery groups or through working in partnership with, or supporting the work of, others;
- Increasing PCSP awareness with the public and key stakeholders by planning communications activity to more proactively inform and promote the work of the PCSP.

Strategic Objective 2 – to improve community safety by tackling crime and anti-social behaviour through:

- Ensuring that local statutory bodies and agencies deal with the anti-social behaviour and crimerelated issues that matter in their area;
- Providing comprehensive community input into decision making processes about tackling antisocial behaviour and giving feedback on the effectiveness of interventions;
- Identifying and implementing, with support from DoJ, ways to educate communities about the realities of anti-social behaviour;
- Contributing to delivery of the Community Safety Strategy action plans, and initiatives that improve community safety;
- Working in partnership with the police, local statutory bodies, agencies and the community to reduce the impact of anti-social behaviour and crime on the community.

POLICING AND COMMUNITY SAFETY PARTNERSHIP

Strategic Objective 3 – to support community confidence in policing through:

- Ensuring local accountability through the Policing Committee's role in monitoring police performance:
- Ensuring that policing delivery reflects the involvement, views and priorities of local communities;
- The inclusion of initiatives/projects in PCSP plans, aimed directly at meeting the objectives of the Northern Ireland Policing Plan;
- Ensuring the PCSP Plan identifies priorities for consideration in the development of the local Policing Plan which are consistent with the Northern Ireland Policing Plan.
- Ensuring improved policing service delivery in partnership with local communities to build and strengthen public confidence in policing;
- Ensuring effective engagement with the police and the local community, with specific emphasis
 on engagement with young people and disadvantaged communities, particularly within Loyalist
 and Republican areas.

Partnership planning has been cognizant of the strategic objectives set out in the Programme for Government, the Northern Ireland Policing Plan and the Northern Ireland Community Safety Strategy.

Causeway Coast & Glens PCSP's Policing Committee has debated and agreed the local policing plan priorities with the Area Commander.


Partnership objectives were achieved through joint working with the public, voluntary, private and community sectors at a local level. A wide range of organisations have a role in developing programmes and actions that will systematically tackle the underlying causes of crime and anti-social behaviour, rather than simply dealing with the problems which present.

POLICING AND COMMUNITY SAFETY PARTNERSHIP STRUCTURE

Causeway Coast and Glens Policing and Community Safety Partnership consists of 10 elected members (3 DUP, 3UUP, 2SF,1SDLP and 1TUV), 9 independent members appointed by Northern Ireland Policing Board (NIPB) and statutory organisations appointed via an Assembly designation process, as follows:

Safe Village

Bushmills became the first village in Northern Ireland to be recognised as a 'Safe Village' for its efforts to raise awareness of the range of services available for anyone living, working or visiting the village, who may be experiencing domestic violence or abuse. This initiative was funded by Causeway Coast and Glens Policing and Community Safety Partnership and delivered in partnership with Onus.

Safe Village is a new community based initiative developed by Onus with the aim of empowering local communities to identify the harm caused by domestic violence and abuse. Safe Village is one of the latest 'Pathways for Participation' to facilitate effective partnership working in supporting people.

Graffiti Removal Scheme

This scheme helps maintain a graffiti-free environment throughout Causeway Coast and Glens, by enabling prompt action to remove graffiti.

On receipt of reports from PCSP members, police, elected representatives, council staff or residents, a check is carried out to determine ownership of the property or site and assess if it is the responsibility of a statutory partner or falls under the remit of the PCSP Scheme criteria. Once this is established, removal is actioned or a referral made to the appropriate partner.

The scheme sees an appointed contractor respond to incidents of graffiti across the council area within a 48 hr period.

Through the work of PCSP, Causeway Coast and Glens Borough Council was recognised for its workplace policy on domestic abuse when it received a Gold Award at The Onus Workplace Charter Awards. The policy ensures that Council responds effectively to all disclosures of abuse and provides assistance and support for victims.

PCSP worked in partnership with Onus on this initiative, sharing a common goal of creating a society with a zero tolerance approach to domestic abuse.

Alive and Well

In total, 517 people attended these events across the Causeway Coast and Glens area. The programme was funded and facilitated by a partnership made up of Causeway Coast & Glens Policing and Community Safety Partnership, Causeway Older Active Strategic Team and the Community Navigator for Older People. The programme was rolled out in Ballymoney, Bushmills, Limavady and Portrush.

The aim was to give older people information and support to stay safe and well at home. Content included talks on Crime Prevention and COAST Handyman Service, alcohol awareness and volunteering. Participant feedback was overwhelmingly positive in respect of the benefits to older people from participation. This initiative delivers significant signposting opportunities to other services.

PSNI participation in this programme is crucial in respect of engagement and advice.

Counter Measures Training

Bar staff from across the borough have received training aimed at reducing alcohol related harm. The Counter Measures programme was facilitated by Causeway Coast and Glens Borough Council's Policing and Community Safety Partnership (PCSP).

It allows participants to keep up to date with new liquor licensing laws and the Responsible Retailing Code of Practice for the sale and promotion of alcohol.

The training highlighted the potential harm of excessive alcohol consumption, and made staff aware of new legal duties within the licensed environment of a pub or club.

The courses were delivered in Limavady, Ballycastle, Ballymoney, and Coleraine.

Business crime events across the borough

Crime Prevention Toolkit for Local Businesses

A joint campaign by Causeway Coast and Glens Policing and Community Safety Partnership and local Police provided local businesses with a crime prevention toolkit.

The kit included a good practice guide, a risk self-assessment form, a retail crime reduction guide and a business crime newsletter. The aim is to support businesses in protecting their staff and their property from criminals.

As well as the toolkit, police also deliver a SafeShop scheme for businesses, which provides practical training for staff working in retail premises.

It outlines steps that staff can take to stop shoplifting and what they can do if they actually catch someone shoplifting in their premises.

This initiative was launched at business events in Ballycastle, Ballymoney, Coleraine and Limavady.

Online Drug Dangers

Causeway Coast and Glens PCSP, in Partnership with PSNI and Crimestoppers, delivered a campaign to highlight the growing issue of young people ordering drugs online.

The campaign was targeted at parents, urging them to be aware of what their children are buying over the internet, encouraging greater vigilance in respect of items arriving by post.

The police message in respect of this campaign was that monitoring what your children are accessing online can keep them safe from a lot of potential dangers.

Parents were encouraged to speak openly to their children about the dangers of illegal drugs including psychoactive substances, ensure the appropriate settings are activated on their devices and to take an active interest in any packages delivered to home, addressed directly to children.

Independent charity, Crimestoppers, was also part of this important awareness raising campaign.

Drug Dealers Don't Care Campaign

In partnership with Crimestoppers, PCSPs across Northern Ireland launched a campaign highlighting the damage drugs do to individuals, families and communities and urged the public to report drug dealers.

This NI wide campaign featured viral videos alongside bus, adshel, online and radio advertising and also encouraged those taking drugs to question their choices and to realise the negative impact that drug use, even recreational, can have on their family, working and social life.

PCSP is committed to highlighting the impact of drugs on our communities and to give confidence to communities to report drug dealing and make our communities safer places for everyone.

This campaign coincided with the Police Service of Northern Ireland's 2017 'Operation Torus', which targets street level drug dealers. Operation Torus ran for four weeks during which time officers disrupted and arrested those involved in the sale and supply of drugs.

Where is Your Child Tonight?

Where is Your Child Tonight? was delivered across the Council area in the run up to Halloween.

The project targeted local parents, urging them to pay attention to the whereabouts of their children at all times.

The initiative, funded by PCSP, also aimed to stimulate debate around the key community safety issues of illegal fireworks, alcohol mis-use and anti-social behaviour which are all problematic at this time of year.

This initiative was supported by PSNI and Northern Ireland Fire and Rescue Service with joint key messages across agencies.

Cybersafe

In a joint approach by the Education Authority of Northern Ireland and PCSP, this project targeted students in post-primary schools across the Causeway Coast and Glens Borough Council area.

The Cyber Safe project was designed to act as a visual reminder, with local signposting helping young people affected by online bullying.

Student resources carrying the message "Sticks and stones or clicks & phones... online bullying is still wrong" were distributed during school visits across the borough, with staff speaking to pupils about the dangers and consequences of online bullying and internet safety.

The project was designed to help young people, who may feel isolated and vulnerable as a result of cyber bullying, find the support they need before the bullying escalates.

It also offers a message to those involved in online bullying. It tells them that it is real bullying, that it is wrong and that it is being tackled by police.

Neighbourhood Watch Conference

Causeway Coast and Glens Policing and Community Safety Partnership hosted a Neighbourhood Watch conference in the Magherabuoy Hotel, Portrush for Co-ordinators of some of the 56 local schemes currently in operation across the council area, covering approximately 2,706 households.

Neighbourhood Watch is a partnership between local communities, the Police and PCSPs, with the aim of helping people protect themselves and their property and reduce the fear of crime.

The scheme creates effective communication between residents and the police, with local co-ordinators acting as the primary point of contact.

Neighbourhood Watch is an important mechanism for local communities to protect themselves and to look after friends, family and neighbours. Across the UK, it has been proved effective in addressing crime, fear of crime and anti-social behaviour.

The conference provided an excellent opportunity for dialogue around current community safety concerns between co-ordinators and PSNI. There was also an interactive element with role play scenarios.



Domestic Abuse

Causeway Coast and Glens Policing and Community Safety Partnership, Women's Aid and local police reminded abuse victims that they can take steps to make 2017 a better year.

By re-launching our 'Walking on Eggshells' campaign, we sought to raise awareness around what domestic abuse is and what steps victims can take to make it stop. Through the campaign, we encouraged all victims to come forward and report the matter to the police with the strapline "Speak out to stop it".

The police role is about prevention, protection and prosecution – to prevent further violence, to protect the victim, children and other vulnerable people and to facilitate the prosecution of offenders. They work closely with statutory and voluntary partners, to ensure the victims get the help they deserve, to highlight the issue of domestic abuse and to explore ways in which we can keep communities safer.

There are dedicated domestic abuse officers across Northern Ireland to ensure that all domestic abuse crimes are investigated, as well as providing support and information to victims about police procedures and legal proceedings.

Domestic abuse cannot be dealt with solely by the police and it is important that the partnership work continues in order to highlight the issue of domestic abuse and explore ways in which we can all make our communities safer. The PCSP also works closely with Women's Aid in relation to the support offered to victims and early intervention in schools.

Causeway Coast and Glens PCSP Blocks Nuisance Calls

Causeway Coast and Glens PCSP, in Partnership with COAST (Causeway Older Active Strategic Team), has undertaken a project which sees the provision of call blocker devices to prevent repeated cold calling to elderly and vulnerable residents across the borough council area.

This project worked closely with the PSNI Crime Prevention Officer, thereby enabling a targeted approach and ensuring that those most in need of these devices availed of them.

Call Blockers have been very well received by those residents tormented by nuisance calls which can have a far-reaching negative impact on the elderly and vulnerable in the community.

Safe Home Scheme

Safe Home is a multi-agency partnership project whereby police refer victims of crime and those who are vulnerable are referred by social workers, family members, older persons groups as well as self-referrals.

Safe Home has beneficiary selection criteria to ensure that the service is targeted at the most vulnerable. The project is delivered by Be Safe Be Well across the council area.

The project is delivered via a bespoke home visit where an assessment is undertaken in respect of security needs and participants have the opportunity to have appropriate equipment installed.



Drink Drive - New Legislation

Police in Causeway Coast and Glens conducted a number of random breath checks at vehicle checkpoints in the run up to Christmas as part of the annual winter drink drive campaign.

New legislation gives police another tool to help prevent people taking life-threatening, unacceptable, risks as there is no such thing as a safe limit and one drink can impair ability to drive.

Previously, police officers needed a reasonable suspicion about the manner of someone's driving, have seen a moving traffic offence, or been called to a collision before requiring a preliminary breath test from a driver. The new legislation means police can establish vehicle checkpoints solely for the purpose of carrying out random breath tests.

PCSP is fully supportive of the PSNI zero tolerance approach to drink driving at any time of year and welcomed this new legislation to help prevent injury or loss of life on our roads.

Policing Committee Engagement

The Policing Committee met in Ballymoney High School where PSNI had an opportunity to engage with pupils and create a dialogue which will hopefully translate into local communities for the benefit of all.

PCSP understands the importance of community engagement to promote confidence in policing and engagement with local young people is crucial in the identification of priorities and building relationships.

Young people are an important part of our community and their views on policing and how police engage with them really matter. At the event Police spoke to large numbers of students and heard about their experiences and ideas.

It was also an opportunity for students to meet with officers from various departments within the service as there was representation from Dogs Unit, Crime Scene Investigators and Roads Policing to name a few.

The officers who attended found the event worthwhile. They welcomed the opportunity to listen to the conversations taking place and valued the chance to address a few myths and perceptions.

2 Fast 2 Soon

PCSP joined forces with the PSNI and NIF&RS to drive home the importance of road safety at an event in Coleraine town centre, specifically focusing on young drivers.

Two road traffic collision demonstrations were played out, with fire fighters using cutting equipment to show what happens in a real life crash scenario.

The events also featured the PCSP's car crash simulator and the primary objective was to encourage better driving and a safer approach to getting behind the wheel.

The event was timed to coincide with schools preparing for their mid-term holidays. The PCSP and the emergency services took the opportunity to emphasise the need for safety on the roads at all times. The crash simulator delivers a timely reminder of the potential consequences which can result from poor decisions.

Accident demonstrations are a powerful way to share the road safety message, and PSNI and the NIF&RS are key partners.

Last Orders

Due to the level of demand from post-primary schools and Further Education Colleges, the Last Orders programme was once again delivered in post-primary schools across the council area. This hard-hitting drama and programme of facilitated workshops targeted year 10 pupils and explored the themes of alcohol, anti-social behaviour and the consequences and impact of risk-taking behaviours.

This educational and preventative programme helped pupils explore consequences and legalities as well as looking at the physical, mental and emotional impacts of such behaviours.

Developed by a team of doctors, NSPCC professionals and teachers, "Last Orders" is a professional and specialist theatre company production telling the story of three teenagers embarking on an alcohol fuelled night out and exploring the disastrous consequences.

Based on true events, the play is written in a hard-hitting yet humorous style. Following the performance, an interactive workshop involving cast in-character improvisation allows students to explore the themes of anti-social behaviour, illegal purchase, cyber safety and attitudes to risk.

Anti-Social behaviour and alcohol mis-use are key priorities for PCSP and Last Orders engages young people in these issues and enables them to consider consequence and risk.

Performances coincided with Alcohol Awareness Week in November 2016.

CAUSEWAY COAST & GLENS PCSP PROGRAMME OF INITIATIVES 2016-17

Risk Avoidance Danger Awareness

Approximately 1,700 primary school pupils from across the council area had the opportunity to visit RADAR.

This project fits with the PCSP strategic priorities of Early Intervention, Drugs and Alcohol, Anti-Social Behaviour and the emerging issue of E-Safety and is an ideal opportunity to cover a multitude of themes within a single visit.

During the visits, students participated in specialised workshops on issues such as Road Safety, Fire Safety, Drugs & Alcohol, Anti-Social Behaviour and E-Safety.

The project helped further raise awareness of the PCSP and increased collaboration with local schools and has seen excellent levels of engagement by schools across the geography.


RADAR is Risk Avoidance Danger Awareness Resource. It is Northern Ireland's first and only fully interactive safety and life skills education centre. RADAR enables young people to explore dangerous situations in a risk-free setting. It has been designed to inspire, engage and inform young people on how best to keep themselves safe.

Anti-social behaviour leaflet

This year saw re-distribution of a leaflet offering advice and signposting for those affected by antisocial behaviour in the borough.

Working in partnership with PSNI, Causeway Coast and Glens Borough Council and Housing Executive, the PCSP leaflet explains what antisocial behaviour is and who to contact if you believe you are a victim.

The leaflets were made available for collection at Causeway Coast and Glens Borough Council offices in Ballycastle, Ballymoney, Coleraine and Limavady, as well as PSNI's station reception areas and also at Housing Executive offices across the council area.

The 2016-17 PCSP Grant Programme enabled a broad geographical spread of investment in charitable and community-based oganisations working in villages and towns across the Borough from Cushendun to Greysteel and including Bushmills, Limavady and the urban centres of Coleraine and Ballymoney.

Some of the positive results achieved by PCSP investment included:

- * A 'Heading for Healthy Relationships' project delivered by the Causeway Women's Aid organisation enabled teenage males and females in Dungiven, Coleraine, Ballymoney, Bushmills and Limavady to improve their awareness of unacceptable behaviour in relationships. A participant stated "Everyone should be aware of all types of abuse and [warning] signs. It is a great programme that helps give a clear understanding of unhealthy relationships". A supervising teacher stated "...really happy that we could access this for our pupils... gives them time to consider their relationship rights."
- * Academics from the University of Ulster in Coleraine provided technical support to a borough-wide project led by the Causeway Rural Urban Network organisation. Community consultations enabled the digital mapping of a range of community safety issues. The mapping process helped to capture perceptions and to visually illustrate clusters of issues including drug dealing and anti-social driving. A CRUN Officer stated "When [the mapping results are] contrasted with available statistical evidence, a picture of what is important at community level in terms of community safety can emerge. This can feed into local planning processes".
- * A 'Building Better Futures' project helped 71 young people in Limavady to increase their knowledge and understanding of the risks associated with Anti-Social Behaviour. An additional 20 youth were supported to obtain a Level 2 Award in Youth and Community Development. As an outcome of this project, the Roe Valley Residents Association has reported a reduction in risk-taking and anti-social behaviour by youth.
