#### 1. The Mayor's Business

#### 1.1 Congratulations

#### 3. Declarations of Members' Interests

There were no declarations of interest recorded.

#### 4. Presentation on Collective Worship in School Assemblies

The Mayor welcomed Scott Moore, a 17 year old upper 6 student from Strabane Academy.

Members received a presentation on collective worship and were informed that under current law almost all schools in Northern Ireland must hold collective worship and that the schools Board of Governors having no choice over this.

Scott Moore stated that collective worship was not inclusive, it marginalised those with different views, and by promoting one view above others would not let pupils fully understand religion or ethics. He indicated that this viewpoint was shared by varies interest groups, including National Secular Society, Northern Ireland Humanists and various atheist groups. He requested that Council be supportive of this viewpoint.

The following points were made:

- People should be afforded religious freedom.
- This was an attempt to take Christianity out of schools.
- Religion should not just be taught in schools but in homes and be led by example.
- Take the viewpoint of Churches on collective worship.
- There was no need to impose Christianity on someone else.
- Pupils were given choice to opt out of collective worship with parental consent.
- Religion in schools instils morals and values that help children through life

#### 12.1 Parcellink - 18 March 2016

Translink are currently undergoing a period of review and reorganisation in response to an ever changing business environment. As part of this process, it became clear that the parcel delivery side of the business no longer sits within the core public transport aims.

Translink will no longer be offering a Parcellink service from July 2016.

Request for Council to be advised on what alternative service had been put in place following the close of service.
