MAKING IT ALL WORK BUT BIG CHALLENGES AHEAD: New Councils / New NILGA

Our new 11 councils went "live" on 1st April, and fully deserve the plaudits for the overall success of the transition. They are now settling in to their corporate cultures and roles. Councils have embraced their pivotal role as local leaders having received new, or transferred powers in key areas such as Planning, economic development and Community Planning, with Urban Regeneration powers still scheduled to be transferred next year.

NILGA too has been particularly busy, aligning fully to the 11 council structure and communicating with and to the many, many departments, agencies & partners of the Association but particularly our member Councils. We are delivering European Entrepreneurial Region events in local councils, and have been shortlisted for a major international Summit bringing 750 people to Northern Ireland in 2017! As joint secretariat, NILGA has also supported the elected members on the Local – Central Government Partnership Panel through regular briefing and updates. A Draft Work Plan is now out to Councils for input.

Councils have now appointed representatives to NILGA, and we will hold the first meeting of our new Executive Committee on Friday 22^{nd} May 2015. Next month will see our Annual General Meeting, to be held in Downpatrick on 5^{th} June. Both of these meetings will confirm the new political working groups, on matters CRITICAL to COUNCILS including the Economy and Member Development.

Our Flagship annual Conference will be held in La Mon Hotel & Country Club on Thursday 18th June 2015. More details are provided later in this bulletin. Read on to find out more essential information:

<u> Legislation Update – Last Minute.Com is UNACCEPTABLE</u>

Key pieces of reform legislation remain to be finalised by the Assembly. Standing Orders Regulations were initially rejected, and the Department is working urgently to address remaining issues. Vital legislation on establishing statutory partners to join councils in the Community Planning process remains outstanding, as does the Order to establish performance indicators and standards for the 2015/16 financial year. NILGA has met specifically with Minister Durkan and raised the matter formally at the Partnership Panel. It urges the Department and Assembly members to complete the legislative jigsaw, produce straightforward guidance, and to do this before the Assembly's long summer recess.

Financial Impact of Reform – WE MUST GET THE INVESTMENT PROMISED

Councils have — unsurprisingly — defined areas where they are suffering from reduced funding in the post-reform era. Some of these were known before rates were struck — for instance the **swingeing cut of over £2.8m from the Rate Support Grant** provided to less wealthy council districts. It was also known that transferred funding for **maintenance of off-street car parks** was going to be inadequate, despite the poor condition of some parks and the **Executive's pledges to ensure that functions transferring were fit for purpose, properly resourced and rates neutral at the point of transfer.**

Other funding black holes are becoming apparent. Councils are suffering reductions in grants for waste management, clean air, emergency planning and construction products, and are seeing inadequate funding being provided to cover planning consultancy, grass cutting and grants to community and arts groups.

And there's more to come – proposed funding for Urban Regeneration in 2016/17 has fallen by over £12m from original estimates. NILGA ensured that Ministers and the Partnership Panel was made aware of these issues and that a Financial Impact Review is a definite part of the 2015/16 work plan.

NILGA asserts that it is far better to anticipate rather than react to budgetary spending rounds and other financial planning constraints. At the most recent Panel meeting, local government vehemently proposed advance negotiations in regard to the NI Executive's 2016/17 budget agreement, to avoid speculative rates forecasting and financial deficits.

NILGA will also meet the **DSD**, **DARD** and **DFP Ministers** to discuss funding issues, and will be fully engaging with the Assembly's Environment Committee both at the **18**th **June 2015 NILGA Conference** and when NILGA briefs the Committee on key issues arising during the first 100 days of reform the following week. **Reform of Councils should not penalise Councils**.

NISMP – Key Knowledge for Community Plans
Northern Ireland Strategic Migration Partnership (NISMP) provides an advisory and consultative function in relation to migration. NISMP is currently seeking to work with each council in providing the research and data that is needed at a local level to build on the opportunities and meet the challenges of demographic change. Letters have been sent to all chief executives, requesting a meeting with council to outline the work of NISMP and presentations have already been arranged for four councils. An event will be held in the autumn for all councils where council priorities in relation to migration will be examined and an activity roadmap planned. European Entrepreneurial Region (EER) / EU

NILGA has delivered three bespoke events dedicated to EER - Belfast (November 2014), Lisburn (February 2015) and Brussels (March 2015 - as guests of Committee of the Regions and the European Commission).

As a result of the latter input, Ms Johanna Drake, from the Commission, will be in Northern Ireland (QUB) on the 4th and 5th June 2015, and EER will be a component part of her recently announced visit. These three interventions are complemented by the corporate partnerships now enshrined, with events by the following partners branded as EER. Looking beyond these events, to February 2016, in advance of seeking from the Committee of the Regions a Legacy Initiative for 2016/17, it's hoped that DETI/Invest NI would engage in a collaborative flagship event with NILGA, to culminate the Award year itself and build the momentum and investment flow succeeding it. On the EU front, NILGA has developed an EU Capacity Building Tool Kit for Elected Members: 2015-2019. This is a contemporary, experiential and accessible "toolkit" of local government capacity building on EU Funding designed and coordinated by NILGA. It will be a framework support model for the EU related corporate, investment, assessment, technical, community development & decision taking roles of councillors in Northern Ireland, materially assisting them and their Councils to account for and deliver EU policies and practices which will affect Councils new powers and associated decision taking, in a corporately aligned, citizen oriented way.

Over the last three months, NILGA has met with our three Members of the European Parliament and has communicated with the Junior Ministers and the Permanent Secretaries with the aim to secure Technical Assistance for the period 2015-20 to further develop a European programme of work including capacity building for Elected members inputting in the European Programmes Monitoring Committees and seeking to access European Structural and Investment funds as well as other European funds directly through the European Commission and through our EER Partners. nllga Beyond 100 days

TEAM LOCAL GOVERNMENT - PARTNERSHIP PANEL

A full team of Council and NILGA representatives attended the 3rd meeting of the Partnership Panel in Stormont on 28th April 2015.

Also in attendance were Ministers Durkan (DoE, Panel Chair), Hamilton (DFP), Ford (DoJ), O'Dowd (DE) and Storey (DSD).

- The Panel Chair highlighted the successful practical transition to 11 Councils and Panel members from local government reminded the Partnership that Councils had exercised great leadership as well as operational skill to ensure services and new powers were brought in on time.
- 2. Barriers to progress including administrative and legislative delays, together with severe fiscal constraints disproportionately affecting councils were strongly asserted by Council and NILGA representatives, and Minister Durkan called for engagement protocols to be set up. NILGA asserts that it is far better to anticipate rather than react to budgetary, spending rounds and other financial planning constraints.
- 3. Local government vehemently proposed advance negotiations in regard to the NI Executive's 2016/17 budget agreement, to avoid speculative rates forecasting and financial "black holes".
- 4. Panel members welcomed a key presentation on Well Being from the joint Chairs of the Carnegie Trust, Dr Aideen McGinley and Mr John Woods, with agreed outcomes being the practical and political importance of Well Being in terms of government planning and delivery of services, within the new Programme for Government, and Panel members participating in a fact finding visit to Scotland, where Well Being is an intrinsic component of two tier government and delivery of Single Outcome Agreements, cutting away silos and improving outcomes for citizens.
- 5. Panel members were unanimous in pressing for an early review of elements of the Code of Conduct, and welcomed the Panel Chair's confirmation that he would be facilitating further meetings to resolve areas which are unsatisfactory it is after all Council Elected Members who have to adhere to the Code.
- 6. Minister Hamilton led a discussion on Shared Services, and Local Government Panel members supported the principles underlying the initiatives, including tangible savings of tens of millions of pounds in terms of new back office and technology initiatives within NI Direct, with a strong caveat that Councils, as sovereign entities, had many examples of effective and efficient practices to



deliver high quality services at affordable costs, would continue to engage with central government but, also, would practice innovative self help, in terms of regional collaboration and creative service delivery in the interests of its ratepayers and staff.

- 7. Local Government Panel Members and many Ministers present supported the development of the Draft Work Plan for the Partnership panel, which concentrates on critical, high level material issues such as Effective Public Service delivery, stronger local democracy, ensuring Councils have the proper resources to deliver existing and proposed new services, and ensuring local authorities have a formal, council led, role in the new Programme for Local Government. Councils will receive the draft Work Plan in early May 2015 from NILGA as Joint Secretariat, for corporate input and strategic endorsement, channelled via their Panel representative and Chief Executive.
- 8. MLA training initiatives undertaken by "Politics Plus" will be further explored through NILGA to support the development of elected members in local government, commencing with Partnership Panel Members engaging in a facilitated session later in 2015.
- 9. Local Government members voiced unanimous concern that meetings of the Panel had to be bought into by all Government departments, sought formal input into the Review of the NI Assembly, and the numbers – and roles – of new departments and requested the NI Executive to determine lead bodies for the currently fragmented rural proofing policy and consequent financial deficits.
- 10. Council and NILGA Panel members pressed for confirmation from the Chair that clarity would be sought / restated regarding unresolved insurance claims and associated liabilities lodged before April 2015 for transferred car parks and other capital assets.
- 11. The Panel resolved to have a further Panel Meeting to maintain momentum and delivery, before July 2015.
