1. Proposed Changes to Speed Limit on B16, Bellaghy Road, Dunloy

Correspondence has been received from Department for Regional Development with reference to the proposed changed to speed limit on B16, Ballaghy Road, Dunloy.

TransportNI in consultation with the PSNI have reviewed the speed limits through the village of Dunloy and having examined a number of options it was agreed to take forward a proposal to introduce a 40mph buffer on the B16 Bellaghy Road to help reduce vehicle speeds on the approach to the village. To provide a sufficient length of 40mph restriction that will allow police enforcement, a slight reduction in the length of the existing 30mph speed limit will be required. The new 30mph speed limit, while being slightly closer to the village, will still commence in advance of the main housing development (plan attached).

Before proceeding with the drafting of the appropriate legislation, written comments from elected members are welcomed on this proposal by Friday 9th October 2015.

2. Rathlin - Councillors Meeting

In the previous period of Moyle District Council, Rathlin Development & Community Association (RDCA) had developed a good practice with Councillors of meeting a couple of times a year on Rathlin to keep each other informed of issues and opportunities, as well as to discuss options for support and development. Those meetings were felt to be very helpful and constructive, providing good opportunity for building good relationships for mutual benefit.

A visit was hosted in June and RDCA would like to extend an invitation again to the Causeway Coast and Glens Councillors to re-establish a programme of meeting with members of the RDCA Committee a couple of times a year on the island. Given this crucial stage of the consolidation of good Council practice, particularly with the new obligations of community planning, RDCA would welcome this opportunity to continue the good relations enjoyed before the new Council structures began.

They consider that Rathlin has reached an important point in its development with projects such as the new ferry, harbour developments, consideration of harbour area improvements to transport and parking, the progress of the wind turbine project, the new RSPB/CIL visitor facilities, work towards development of the Kelp Store, and recognise the important part the Council will play in many of these advances, to the benefit of the island community and the many thousands of visitors to the area.

They are also about to begin the second review period of the Rathlin Policy Action Plan and, again, feel that Councillors engagement in this process is very important.
